

Privacy Notice (Applicant)

The **Data Controller** connected with this **Privacy Notice** is Dawn Sandoval Residential Ltd

1. Purpose

In this instance your data is being processed for the specific purpose of providing you with information about properties you may wish to consider renting or buying

2. Lawful Basis

The collection of your data for this purpose is under the **Lawful Basis** of Legitimate Interest because we require this information so that we may communicate with you in order to provide our service

3. Information Collected

The personal data we will collect and process about you in connection with this purpose is:

- 3.1. Name
- 3.2. Address
- 3.3. Telephone number(s)
- 3.4. Email Address

In addition, we may collect other non-personal data regarding your property preferences

4. Website Data Collection

For consumers interacting with us via our website, you should be aware that we do not use any Cookies or analytical tools to gather data from you whilst you visit our website.

5. Retention

Under the **Lawful Basis** referenced in paragraph 2, your data will be retained for a period of 6 years in order that we may administer any investigation by The Property Ombudsman or defend any legal claim you might bring against the Company. This retention period will commence from the date of any final communication you have with us.

6. Destruction

At the end of this retention period your data will be destroyed using an approved method unless prevented by Court order.

7. Data Sharing

Whilst we control your personal data we will need to share this data with the following parties, for the following purposes, in order to provide you with the services you are seeking from us:

- 7.1. Estates IT Ltd for the sole purpose of maintaining a consumer database so we can provide you with our service.
- 7.2. Cortec IT Solutions Ltd for the sole purpose of storing our Company's electronic data (consumer database and associated records).
- 7.3. The Property Ombudsman for the sole purpose of administering any investigation by them.
- 7.4. The Company's insurers, Hiscox for the sole purpose of defending any claim brought against the Company.

- 7.5. The Company's legal advisers, (who are not retained, but whose details will be provided to you in the event that you commence proceedings against the Company,) for the sole purpose of defending any claim.

8. Rights of the Data Subject

- 8.1. Under the General Data Protection Regulation, you, the Data Subject have certain rights regarding the control and processing of your personal data. Details regarding your rights can be found on the Information Commissioner's Office (ICO) [website](#).

9. Security

- 9.1. Recognising the importance of personal data to our consumers, we endeavour to put in place appropriate organisational and technical measures to protect that data.
- 9.2. Personal data we hold on electronic media is encrypted and stored in a secure data centre located in the UK.
- 9.3. Personal data we hold on non-electronic media is held in files, which are secured in lockable cabinets in offices with access controls and with 24-hour manned security.
- 9.4. **Data Subjects** should be aware that not all electronic communications are secure. We use Transport Layer Security (TLS) to encrypt and protect email traffic in line with government advice. However, if your email service does not support TLS, you should be aware that any emails we send or receive may not be protected in transit.
- 9.5. We will also monitor any emails sent to us, including file attachments, for viruses or malicious software. Please be aware that you have a responsibility to ensure that any email you send is within the bounds of the law.

10. Additional Services

As a consumer of our services we may occasionally contact you to make you aware of other similar services we offer, which we feel could be of assistance to you. Such communications will be sent to you under the Privacy and Electronic Communications Regulations and you will be given the option to opt out of similar communications on each occasion.

11. Data Protection Concerns
