6. Destruction

At the end of this retention period your data will be destroyed using an approved method unless prevented by Court order.

7. Data Sharing

Whilst we control your personal data we will need to share this data with the following parties, for the following purposes, in order to provide you with the services you are seeking from us:

- 7.1. Estates IT Ltd for the sole purpose of maintaining a consumer database so we can provide you with our service.
- 7.2. Cortec IT Solutions Ltd for the sole purpose of storing our Company's electronic data (consumer database and associated records).
- 7.3. The Property Ombudsman for the sole purpose of administering any investigation by them.
- 7.4. The Company's insurers, Hiscox for the sole purpose of defending any claim brought against the Company.

7.5. The Company's legal advisers, (who are not retained, but whose details will be provided to you in the event that you commence proceedings against the Company,) for the sole purpose of defending any claim.
