

Privacy Notice (Landlord)

The **Data Controller** connected with this **Privacy Notice** is Dawn Sandoval Residential Ltd

1. Purpose

In this instance your data is being processed for the specific purpose of letting your property, for which you have instructed us to act on your behalf as your agent.

2. Lawful Basis

The collection of your data for this purpose is under the **Lawful Basis** of Contract, because we require this information to facilitate a contract relating to the letting of your property.

3. Information Collected

The personal data we will collect and process about you in connection with this purpose is:

- 3.1. Name
- 3.2. Address (both for the property to be let and correspondence if they are different)
- 3.3. Telephone number(s)
- 3.4. Email Address
- 3.5. Bank Details (so we may pay you your rent in due course)

In addition, we may collect other non-personal data regarding your property.

4. Retention

Under the **Lawful Basis** referenced in paragraph 2, your data will be retained until the end of the financial year in which you request that we no longer act as your agent in connection with the property and then for a further 6 years after that in order to comply with HMRC requirements regarding financial record keeping and accounting. This retention period will commence from the date of your instruction to us to cease acting as your agent.

5. Destruction

At the end of this retention period your data will be destroyed using an approved method unless prevented by Court order.

6. Data Sharing

Whilst we control your personal data we will need to share this data with the following parties, for the following purposes, in order to provide you with the services you are seeking from us:

- 6.1. Estates IT Ltd for the sole purpose of maintaining a consumer database so we can provide you with our service.
- 6.2. Cortec IT Solutions Ltd for the sole purpose of storing our Company's electronic data (consumer database and associated records).
- 6.3. Rightmove Group Ltd (Property Portal) for the sole purposes of advertising your property for rent.
- 6.4. The tenant for the sole purpose of drawing up and executing any Tenancy Agreement.
- 6.5. Property CGI Ltd for the sole purpose of arranging to photograph and draw up a floorplan of your property.

- 6.6. Maitlands Acorn Professional Ltd for the sole purpose of arranging an EPC certificate of your property, should one be required.
- 6.7. FCC Paragon for the sole purpose of referencing the tenant before any tenancy agreement is concluded.
- 6.8. G&G Inventory Services Ltd for the sole purpose of creating an inventory of your property and then conducting the “walk-in” and “walk-out” with the tenant at the start and finish of the tenancy.
- 6.9. JP Project Management Ltd for the sole purpose of property maintenance.
- 6.10. AG Cleaning Services Ltd for the sole purpose of arranging to clean the property, should that be required.
- 6.11. The Local Authority for the sole purpose of managing the tenant’s liability for council tax.
- 6.12. Utility Companies for the sole purpose of managing the tenant’s liability to pay for utility consumption whilst renting the property.
- 6.13. The Property Ombudsman for the sole purpose of administering any investigation by them.
- 6.14. The Company’s insurers, Hiscox for the sole purpose of defending any claim brought against the Company.
- 6.15. The Company’s legal advisers, (who are not retained, but whose details will be provided to you in the event that you commence proceedings against the Company,) for the sole purpose of defending any claim.

7. Rights of the Data Subject

- 7.1. Under the General Data Protection Regulation, you, the Data Subject have certain rights regarding the control and processing of your personal data. Details regarding your rights can be found on the Information Commissioner’s Office (ICO) [website](#).

8. Security

- 8.1. Recognising the importance of personal data to our clients, we endeavour to put in place appropriate organisational and technical measures to protect that data.
- 8.2. Personal data we hold on electronic media is encrypted and stored in a secure data centre located in the UK.
- 8.3. Personal data we hold on non-electronic media is held in files, which are secured in lockable cabinets in offices with access controls and with 24-hour manned security.
- 8.4. **Data Subjects** should be aware that not all electronic communications are secure. We use Transport Layer Security (TLS) to encrypt and protect email traffic in line with government advice. However, if your email service does not support TLS, you should be aware that any emails we send or receive may not be protected in transit.
- 8.5. We will also monitor any emails sent to us, including file attachments, for viruses or malicious software. Please be aware that you have a responsibility to ensure that any email you send is within the bounds of the law.

9. Additional Services
